Have you heard?

Arizona law provides a tax credit for contributions to public schools to support extracurricular activities or character education. You can help Haven students and possibly lower your tax bill by making a donation before December 31 (to claim on both your Federal and State 2018 taxes). You can still contribute through April 15, 2019 to claim on State taxes for 2018 (but Federal would have to wait until 2019!) Directing your Arizona taxes to Haven instead of the state government is a great way to support our school.

How can the Money be Used?

Experiential learning is very important in our Montessori curriculum. In an age of repeated budget cuts, the "extras" are often the first to go. Tax credit contributions supplement the costs associated with field trips, guest speakers, the arts, languages, and physical education. By donating to our school's tax credit program, students receive an even more enriched education.
